

**NATIONAL BOBSLEIGH PROGRAM  
NATIONAL DEVELOPMENT BOBSLEIGH PROGRAM  
2016/17 FEE SCHEDULE**

In addition to signing the **Bobsleigh CANADA Skeleton (BCS)** Athlete Agreement and fulfilling any other requirements as may be notified from time to time, Athletes who are selected to the **World Cup Bobsleigh Team (WCBT)** or **NextGen Bobsleigh Team (NGBT)** as part of the **National Bobsleigh Program (NBP)** or **National Development Bobsleigh Program (NDBP)** are assessed the following fees:

**A. National Membership Fee (NMF)**

- i. The NMF of **\$475** is payable in full on or before **September 30<sup>th</sup>, 2016.**

The NMF shall be used to cover costs relating to:

1. BCS Class B Membership;
2. CAIP – Bronze Level\* coverage;
3. CAIP – out of country insurance; and/or
4. IBSF e-license registration.

*\*Athletes may choose to upgrade to Silver or Gold Level for an additional \$145 or \$315 respectively. This must be done at the time of enrollment. Please see the following link for information about CAIP:*

**AND**

**B. Athlete Program Fee (APF)**

The following APFs are payable, (subject to the APF Reduction set out in paragraph iii below):

i. **WCBT APF**

**\$3,000** payable in installments:

- 1) Installment 1: **\$1,500** due on or before **November 1<sup>st</sup>, 2016;** and
- 2) Installment 2: **\$1,500** due on or before **December 28<sup>th</sup>, 2016.**

**OR**

ii. **NGBT APF**

a. **NGBT APF 1**

*(Pre-season sliding, NAC Calgary, NAC Whistler, WC Whistler)*

**\$3,000** payable in installments:

- 1) Installment 1: **\$1,500** due on or before **October 7<sup>th</sup>, 2016;** and
- 2) Installment 2: **\$1,500** due on or before **November 1<sup>st</sup>, 2016.**

**AND**

b. **NGBT APF 2A**

*(WC Lake Placid, WC Koenigssee, WC Igls, ITW/WCh Sochi, ITW/WC PyeongChang)*

**\$3,500** payable in installments:

- 1) Installment 1: **\$1,500** due on or before **December 28<sup>th</sup>, 2016;** and
- 2) Installment 2: **\$2,000** due on or before **February 6<sup>th</sup>, 2017.**

**OR**

**c. NGBT APF 2B**

*(NAC Park City, NAC Lake Placid)*

Fee to be confirmed.

iii. **APF Reduction:**

Athletes who placed 1<sup>st</sup> – 3<sup>rd</sup> in the 2016 World Championships shall have their respective APF waived.

**C. NMF & APF Terms**

- i. Fees may be paid by cash, cheque, Interac e-Transfer, or credit card\*\* (Mastercard or VISA)

- iii. An Athlete who fails to pay the NMF and or respective APF shall cease to be a "member in good standing" of the BCS, with all associated consequences, including but not limited to exposing the Athlete to disciplinary action.
- iv. For the avoidance of doubt, no Athlete shall be eligible to travel, compete and/or receive benefits of the NBP/NDBP without paying the NMF and respective APF or making payment plan arrangements with BCS in advance.
- v. BCS reserves the right to:
  1. enter non-NBP/NDBP athletes in national and/or international competition. Such Athletes shall not be Members of the NBP/NDBP but shall be required to pay such fees as may be assessed and/or to meet such other requirements as may be notified from time to time, including but not limited to proof of insurance;
  2. make adjustments to the training and/or competitive programming and/or schedule; and/or
  3. adjust the respective APFs according to the team to which the athlete is selected based on capacity and/or budget constraints.

\*\*Athletes who choose to pay their fees by credit card (Mastercard or VISA) will be charged a credit card processing surcharge of **2.65%**. This surcharge is a direct cost to BCS and is paid directly to the credit card processing company.
