

# NATIONAL BOBSLEIGH PROGRAM WORLD CUP BOBSLEIGH TEAM 2017/18 FEE SCHEDULE

In addition to signing the **2017/18 Bobsleigh CANADA Skeleton (BCS) Athlete Agreement** and fulfilling any other requirements as may be notified from time to time, Athletes who are selected to the **World Cup Bobsleigh Team (WCBT)** are assessed the following fees:

## A. <u>National Membership Fee (NMF)</u>

i. The NMF of \$585 is payable in full on or before October 16th, 2017.

The NMF shall be used to cover costs relating to:

- 1. BCS Class B Membership;
- 2. CAIP Bronze Level\* coverage;
- 3. CAIP out of country insurance; and/or
- 4. IBSF e-license registration.

\*Athletes may choose to upgrade to Silver or Gold Level for an additional \$230 or \$560 respectively. This must be done at the time of enrollment. If you are currently enrolled in CAIP you cannot make changes or upgrade until your annual renewal date. Please see the following link for information about CAIP: <u>http://www.mkirsch.ca</u>

### B. WCBT Athlete Program Fee (APF)

- i. The **WCBT APF** of **\$3,000** is payable in two (2) installments as follows: (subject to the APF Reduction set out in section **B.ii**.)
  - 1. Installment 1: **\$2,000** due on or before <u>October 23<sup>rd</sup>, 2017</u>; and
  - 2. Installment 2: \$1,000 due on or before December 20th, 2017.

#### ii. APF Reduction:

Athletes who placed 1<sup>st</sup>, 2<sup>nd</sup> or 3<sup>rd</sup> in the 2017 World Championships shall have their WCBT APF waived.

### C. <u>NMF & APF Payment</u>

- i. Fees may be paid by cash, cheque, Interac e-Transfer, or credit card\*\* (Mastercard or VISA)

\*\*Athletes who choose to pay their fees by credit card (Mastercard or VISA) will be charged a credit card processing surcharge of **2.65%**. This surcharge is a direct cost to BCS and is paid directly to the credit card processing company.



### D. <u>NMF & APF Terms</u>

- i. An Athlete who fails to pay the NMF and or WCBT APF shall cease to be a "member in good standing" of the NBP and/or BCS, with all associated consequences, including but not limited to exposing the Athlete to disciplinary action.
- ii. For the avoidance of doubt:
  - 1. No Athlete shall be eligible to travel, compete and/or receive benefits of the NBP without paying the NMF and WCBT APF or making payment plan arrangements with BCS in advance and adhering to such payment schedule on an ongoing basis; and
  - 2. The NMF and WCBT APF are non-refundable.
- iii. BCS reserves the right to:
  - 1. Enter non-NBP athletes in national and/or international competition. Such Athletes shall not be Members of the NBP but shall be required to pay such fees as may be assessed and/or to meet such other requirements as may be notified from time to time, including but not limited to proof of insurance;
  - 2. Make adjustments to the training and/or competitive programming and/or schedule; and/or
  - 3. Adjust the WCBT APF based on unforeseen circumstances and/or other considerations including, but not limited to capacity and/or budget constraints.
