

NATIONAL SKELETON PROGRAM WORLD CUP SKELETON TEAM 2018/19 FEE SCHEDULE

In addition to signing the **2018/19 Bobsleigh CANADA Skeleton (BCS) Athlete Agreement** and fulfilling any other requirements as may be notified from time to time, Athletes who are selected to the **World Cup Skeleton Team (WCST)** as part of the **National Skeleton Program (NSP)** are assessed the following fees:

A. <u>Travel Medical Insurance Fee (TMIF)</u>

i. The TMIF of **\$210** is payable in full on or before *November 1st, 2018.*

The TMIF provides insurance coverage through the Canadian Athlete Insurance Program (CAIP) while traveling outside of Canada.

AND

B. WCST Athlete Program Fee (APF)

- i. The WCST APF of **\$6,500** is payable in two (2) installments as follows:
 - 1. Installment 1: \$4,500 due on or before November 1st, 2018, and
 - 2. Installment 2: **\$2,000** due on or before *January 15th, 2019*.

C. TMIF & APF Payment

- Fees may be paid by cash, cheque, Interac e-Transfer, or credit card** (Mastercard or VISA)

Athletes who choose to pay their fees by credit card (Mastercard or VISA) will be charged the credit card processing surcharge of **2.75%. This surcharge is a direct cost to BCS and is collected directly by the credit card processing company.

D. TMIF & APF Terms

- i. An Athlete who fails to pay the TMIF and/or WCST APF shall cease to be a "member in good standing" of the NSP and/or BCS, with all associated consequences, including but not limited to exposing the Athlete to disciplinary action.
- ii. For the avoidance of doubt:
 - 1. No Athlete shall be eligible to travel, compete and/or receive benefits of the NSP without paying the NMF and WCST APF; and
 - 2. The TMIF and WCST APF are non-refundable.
- iii. BCS reserves the right to:



- 1. Enter non-NSP athletes in national and/or international competition. Such Athletes shall not be Members of the NSP but shall be required to pay such fees as may be applicable and meet such other requirements as may be notified from time to time, including but not limited to proof of insurance;
- 2. Make adjustments to the training and/or competitive programming and/or schedule; and/or
- 3. Adjust the WCST APF based on unforeseen circumstances and/or other considerations including, but not limited to capacity and/or budget constraints.
